

Benefits

- You can save the tax on the costs associated with your home whilst living and working in a remote area
- You can save the tax on your holiday transport

How much can I save?

What can I package?

You can salary package the following expenses:

- Interest you pay on your mortgage for the residence you live in
- · Rent you pay for the residence you live in.
- Your utility bills if you salary package rent or mortgage as a remote area benefit
- · Holiday transport

How can I maximise my pay?

- Firstly determine whether or not you live and work in a remote area
- Check if your employer offers Remote Area Benefits for Salary Packaging
- Complete the Easi Remote Area Benefits Form and Declaration, print and sign
- Obtain a copy of your rental agreement/mortgage statement and utility bills
- 5. Scan the forms and attachments and send to Easi
- Easi will process this deduction through your next salary payroll run and reimburse it to your nominated account

What do I need to know?

- The home must be located in a remote area and must be your primary residence
- · You must work in a remote area
- It is customary for employers to provide remote area assistance in the area in which you work
- The remote area rent, mortgage interest payments or utility bills must be valid payments to a third party
